



IMAS Works Utility Billing

The Utility Billing module handles the maintenance and billing of all types of Utilities and Services – metered and unmetered.

CALCULATES AND PRINTS COMMITMENT LIST AND BILLS

- Calculates and prints commitment list in detailed or summarized formats.
- Corrections may be made and the commitment list may be reprinted as often as necessary before utility bills are printed
- Bills may be custom designed to accommodate most every type of bill format.

INTERFACES WITH IMAS Works ACCOUNTS RECEIVABLE MODULE

- Utility bills are processed to the IMAS Works Accounts Receivable system for collection.
- View Invoices option is available from the Utility Billing module for viewing invoice activity by Property or Account.

OTHER STANDARD FEATURES

- As with all IMAS Works modules, standard report formats are provided. Any standard report may be edited and new reports created using Crystal Reports (a Seagate product). Each reporting option has a built in interface to Crystal Reports, making selection and modification of any report easy.
- Any report may be printed to a printer (selected at print time), previewed on the screen, exported to a file, or even emailed internally or via the Internet.
- Pure 32-bit code: Breaks the barriers, providing the platform to take advantage of rapidly advancing technology. Programs are faster and more robust.

- Standard, familiar design to all programs makes learning easy.
- Set View lets users (workstation specific) choose the data they wish to view on the screen with complete control of screen colors, grid multi-color, etc.
- Any screen can be exported to an Excel spread sheet.
